Urban Mobility India Conference

The Urban Mobility India (UMI) Conference and Expo is an annual flagship event of the erstwhile Ministry of Urban Development now Ministry of Housing and Urban Affairs, Government of India with the overarching theme which runs across all the aspects of urban mobility. It is organised by the Institute of Urban Transport (India), a registered Society functioning under the purview of the Ministry. The UMI Conference is mandated by the National Urban Transport Policy of the Government of India, 2006 (NUTP). The objective of the Conference is to bring together urban transport professionals and officials in the country as well as international experts under one roof to enable them to discuss, share views / experiences and to disseminate up to date knowledge on best practices in urban transport nationally and globally.

Till date 14, Conferences have been successfully held starting from 2008 out of which 12 events were held physically while the last two events in 2020 and 2021 were held virtually due to COVID-19 Pandemic.

Institute of Urban Transport (India)

The Institute of Urban Transport (India) [IUT] located at Anand Vihar Metro Station Building, Delhi, a professional non-profit organization, was set up in May, 1997 as a registered Society under the purview of the erstwhile Ministry of Urban Development (MoUD) now Ministry of Housing and Urban Affairs (MoHUA), Government of India (Gol).
