- 3. The technical bids were evaluated by a Bid Evaluation Committee and the marks obtained by the respective bidders are as under:

4. It would be seen from the above table that three Bidders at SI.Nos.1, 4 and 5 i.e. M/s ALPCORD Network Event & Conferences Management Company Pvt. Ltd., New Delhi, M/s Raj Designs & Exhibits, Lucknow and M/s 7 Days Entertainment, Lucknow have not fulfilled the minimum prescribed criteria of 70 per cent marks and hence they are considered as "Technically Not Qualified".

- 5. The remaining 3 bidders at SI.Nos.2, 3 and 6 i.e. (M/s. KW Conferences, Gurugram, M/s. IndeBo Travels Pvt. Ltd., New Delhi, and M/s PHD Chamber of Commerce & Industry, New Delhi, have got score of more than 70% marks and hence are declared as "Technically Qualified" for opening of Financial Bids.
- 6. The evaluation report has been accepted by the competent authority. The financial bids of the technically qualified bidders will be opened on 05.9.2019 at 1500 hrs at IUT premises in the presence of their respective representatives.
