**Subject: Conducting Opinion Survey** 

#### 1. INTRODUCTION

IUT requires assistance in carrying out an opinion survey as per the details mentioned below:

## **Opinion Surveys:**

Opinion Surveys shall be done through Questionnaires by face-to-face interview from users of public transport services like BRTS, city bus, & Metro as well as other prevalent mode of transport like auto rickshaw, taxi service, private vehicles etc wherever available. Surveys shall be conducted at below mentioned 11 Indian cities for BRTS users (350 samples) and non-users (150 samples) on a digital platform, which can access on real time basis (500 samples per city<sup>1</sup>).

Details like the location name, time, date of survey, should be noted out properly. The scope of the user opinion survey may include various parameters such as Income & % Expenditure on Transport, temporal & spatial variation of trips, travel time, transfer time, convenience, purpose, etc. There would be around 10 - 15 questions.

#### 2. General Instructions

- All survey work locations will be identified by IUT and data collection shall be carried out in the prescribed format given by IUT.
- All survey data sheets shall be provided to IUT upon completion of the survey. The opinion survey needs to be conducted on a digital platform supported by Google or similar applications provided by good quality photographic evidence (minimum 25nos.). The procurement/development of such a platform shall be undertaken by IUT which it can monitor on real time basis. All other ancillary tools/support system (including mobile & data, if required) for conducting the survey shall be entirely borne by the selected consultant.
- All survey data needs to be entered in the excel format.
- IUT representative visiting the site shall be extended full cooperation and he/she shall be explained about methodology adopted and shall be appraised about the measures adopted by accuracy of work.
- The schedule of surveys should be approved by the Client before commencement of survey.
   The survey should be commenced in the presence of supervisor.
- The quoted rates shall be inclusive of the cost of labour, materials, equipment, transport, punching of data in prescribed format, and reports etc. and no other charges whatsoever shall be entertained in any circumstances.
- The consultant at its cost shall ensure all road/traffic safety measures.
- Timing The total time for conducting the surveys and submitting the data in excel format is
   2 weeks from the date of award of the mandate letter.

#### 3. Professional Fees

1. Consultant shall have to quote the average fee per user opinion sample survey and total fee.

- 2. The total amount of the fee shall be worked out on the basis of exact number of locations / samples after completion of the assignment. For the initial payments, same shall be worked out by on the basis of number of locations mentioned above.
- 3. The contract will be awarded to the lowest financial bidder subject to meeting the technical qualification and acceptance of the terms and conditions mentioned in this document.
- 4. The financial offer of those firms who do not submit all the requisite documents mentioned in **Annexure-I** will not be considered for evaluation.
- 5. The tenderers shall also furnish a declaration in **Annexure II** on official Letter Head of the agency.
- 6. The quotations for survey along with Annexures and requisite documents duly signed and sealed on each page by authorized signatory, should reach latest by **12:00 hrs**, **08.03.2021** through email at <a href="mailto:events@iutindia.org">events@iutindia.org</a>. The subject mentioned on the mail should be "Quotation for Opinion Survey". The mails should be addressed to the following:
